#### City of TO Municipal code:

#### Sec. 1-4.01. Right to appeal.

Except where an appeals procedure is otherwise specifically provided in this Code, any person excepting to the denial, suspension, or revocation of a license or permit applied for or held by him pursuant to any of the provisions of this Code, or to any administrative decision made by any official of the **City**, if the denial, suspension, or revocation of such permit or the determination of such administrative decision involves the exercise of administrative discretion or personal judgment exercised pursuant to any of the provisions of this Code, may appeal in writing to the **City** Manager by filing with the **City** Clerk a written notice of such appeal, setting forth the specific grounds thereof.

No right of appeal to the **City** Manager from any administrative decision made by an official of the **City** pursuant to any of the provisions of this Code shall exist when such decision is ministerial and thus does not involve the exercise of administrative discretion or personal judgement exercised pursuant to any of the provisions of this Code.

#### 18.300.050 Conduct of hearing on appeal.

- (a) Scope of Hearing. Review of all appeals shall be de novo. The review body is not bound by the decision that has been appealed or limited to the issues raised on appeal.
- (b) Action of Review Body. The review body may continue the matter from time to time, and, at the conclusion of its consideration, may affirm, reverse, or modify the decision appealed and may take any action which might have been taken in the first instance by the body from whose action is being appealed. If new or different evidence is presented on appeal, the review body may also refer the matter for reconsideration to the body whose action is being appealed. (Ord. 9-2014 § 41, 3-4-14.)

#### **RECOMMENDATION:**

#### **FINANCIAL IMPACT:**

**No Additional Funding Requested**. Cost of attendance is included in adopted FY 2015-16 General Fund Budget.

#### **BACKGROUND:**

The League of California Cities (LCC) is an association of California city officials who work together to enhance their knowledge and skills, exchange information, and combine resources so that they may influence policy decisions that affect cities.

Founded in 1898 on the principles of local control and interagency cooperation, LCC has grown from a handful of public officials to include the voluntary membership of 479 California cities. Today, LCC and its member cities are working hard to strengthen the effectiveness of their advocacy efforts. LCC's mission statement reflects this commitment to "restore and protect local control for cities through education and advocacy to enhance the quality of life for all Californians."

#### **DISCUSSION/ANALYSIS:**

LCC coordinates Policy Committees on a variety of topics including Public Safety, Community Services, Environmental Quality, and Revenue and Taxation. Each year, LCC accepts nominations for Councilmembers to participate on these committees. Mayor Joel Price was appointed to serve on the Public Safety Policy Committee (PSPC) as the Channel Counties Division representative for the 2016 term.

LCC hosts quarterly policy committee meetings, and rotates its location from Northern and Southern California venues. PSPC held its quarterly meeting on Friday, April 8, 2016 at the Handlery Hotel in San Diego. PSPC met as follows:

A. Guest Speaker – Chief Steve Lindley, Bureau of Firearms – California Department of Justice, provided an update on 2015 Armed Prohibited Persons System Enforcement Efforts. Chief Lindley advised the Committee that funds for the project have run out. The Department is seeking federal support such as grants to resume the project in the near future.

#### B. League Positions on Public Safety Bills

The Committee discussed bills that the League Board of Directors had taken positions on:

1. AB 1564 (Williams) Emergency Services: Wireless 911 Calls: Routing – League Position: Support

This bill requires the Public Safety Communications Division within the Governor's Office of Emergency Services to work with the California Highway Patrol (CHP) to review call data on routing of 911 calls to assess whether they should be routed to a local Public Safety Answering Point (PSAP) or to a CHP call center.

2. AB 1860 (Alejo) Body Cameras: Grant Program – League Position: Support

This measure requires the Board of State and Community Corrections (BSCC) to develop a grant program to make funds available to local law enforcement entities to purchase body-worn cameras and related equipment and data storage capacity. It creates a special fund, the Body-worn Camera Fund. Bill directs the BSCC to take action maximizing local and state competitiveness in the event federal funds become available to purchase body cameras.

3. **AB 1869 (Melendez) Theft: Firearms** – League Position: Support This bill clarifies that the theft of a firearm valued at \$950 or less is a felony offense, notwithstanding the provisions of Proposition 47, which reclassified a host of felonies. This is a re-introduction of last year's AB 150 (Melendez), which was held in the Assembly Appropriations Committee.

4. SB 1221 (Hertzberg) Firefighters: Interaction with Mentally Disabled Persons – League Position: Support

This bill authorizes the Commission on Peace Officer Standards and Training to extend to firefighters a continuing education course on interaction with mentally disabled persons currently available to law enforcement personnel.

#### C. Legislative Action Items

- AB 1957 (Quirk) California Public Records Act, Exemption: Would require local and state law enforcement agencies to make bodyworn camera footage available 60 days after the commencement of an investigation into misconduct that uses or involves that footage. Committee voted to oppose bill.
- 2. AB 2327 (Cooley) Contacting or Communicating with a Minor: This measure makes it a crime for a person to contact or communicate with a minor, or to attempt to do so with the intent of committing a human trafficking offense, or unlawful sexual intercourse with a minor. The targeted practice is commonly referred to as "luring," and this measure represents the expansion of a provision of existing law. Committee voted to support bill.
- 3. AB 2569 (Melendez) Megan's Law: Registration Requirement: This bill will remove the option under existing law for sex offenders to apply for an exclusion from the Megan's Law internet website if the offender is related to his or her victim. Current law allows exemption for sex offenders whose victims were related to them. The author argues that it will help increase awareness of violent sex offenders and ensure the safety of families statewide. Committee voted to support bill.
- 4. AB 2453 (Rodriguez) Emergency Services: State 911 Advisory Board: This measure would increase the membership of the State 911 Advisory Board by four members, including new members with expertise in telecommunications technology. Pending amendments taken in the Assembly Committee on Utilities & Commerce Committee on March 30th limit the increase in board membership by one member who will have telecommunications expertise. Committee voted to watch bill and not take a position at this time.

- 5. AB 2498 (Bonta) Human Trafficking: This bill ensures the confidentiality of victims of human trafficking by providing that their names, addresses, and images, and those of their family members shall be withheld. It also expedites the disposition of human trafficking cases by adding such cases to the list of criminal offenses (abandonment and neglect of children, sexual offenses against minors, incest) which shall be given precedence by the courts over other cases. Committee voted to support bill.
- 6. AB 2611 (Low) California Public Records Act: Exemptions: This bill would expand an exemption under the California Public Records Act for investigatory or security files created by law enforcement entities, including the Office of the Attorney General, the Department of Justice, the Office of Emergency Services, or local or state law enforcement agencies. It would expressly include, within the scope of the exemption, any audio or video recording created during an investigation, intelligence gathering operation, or the conducting of security procedures. This will apply to data gathered by body cameras and local agency-operated drones, and exempt that data completely from disclosure. It also expressly includes within the scope of the exemption video or data depicting great bodily injury to, or the death of, a police officer in the line of duty. Committee voted to support bill if amended.
- 7. AB 2740 (Low-Lackey) Marijuana Intoxication: This bill would establish a legal level of marijuana intoxication of a minimum of five nanograms per milliliter in a person's blood of Delta-9 THC. Individuals testing at that level would be deemed too impaired to operate a motor vehicle, equivalent to the per se violation of having a blood alcohol level of .08% or higher in the case of impaired driving due to alcohol intoxication. It would be unlawful for a person with such test results to drive. Corroborating evidence of impaired driving would be required, including but not limited to, poor performance on one or more field sobriety tests, unsafe or inattentive driving, statements by the person, or statements by witnesses. Committee voted to support bill.
- 8. SB 823 (Block) Criminal Procedure: Human Trafficking: This bill extends procedural protections under current criminal law for human trafficking victims. Specifically, it expands the authorization for human trafficking victims to petition a court to set aside a conviction and to seal arrest and court records, to any offense committed while the individual was a victim of human trafficking, not merely the offense of

prostitution as provided under current law. Committee voted to oppose bill unless amended.

- 9. **SB 1046 (Hill) Ignition Interlock Devices for DUI Offenders:** This bill expands an existing four-county program statewide and requires all persons convicted of Driving Under the Influence (DUI) offenses to install and maintain an Ignition Interlock Device (IID), a breathalyzer requiring a driver to blow into a mouthpiece in order to start a vehicle's engine. It may also require another breath sample at random times after the engine has been started, primarily to prevent a person other than the driver from providing the breath sample. *Committee voted to support bill.*
- 10. SB 1286 (Leno) Peace Officers: Records of Misconduct: This bill seeks to establish a measure of transparency between local law enforcement agencies and the community they serve in the area of misconduct of peace officers. Committee voted to oppose bill.
- 11.SB 1462 (Huff) Vehicles: Driving Under the Influence: Drug Testing: This measure provides that an oral fluids test indicating the presence of a controlled substance based on a sample in order to establish that a person was operating a motor vehicle in violation of existing drinking and driving laws is a field sobriety test, and may be used by an officer as a further investigative tool. Committee voted to support bill.
