Nick,

It is very difficult to answer that question as the State preempts the City from regulating these 6 or fewer bed licensed facilities in residences. State law requires a local jurisdiction like the City to treat these homes like any other residential occupancy. From a City Code Compliance standpoint, we will investigate complaints involving such facilities the same as any other residence, if the complaints are not solely about a licensed 6 or fewer bed facility being present. I really don't have any data on what the actual impact is to a neighborhood, but we do not see a disproportionate number of complaints involving these facilities on verified Municipal Code violations. These type of licensed homes have a wide range of services from youths to senior citizens, so impacts may vary also.
