MULTIPLE RESIDENCE BOUTIQUE AND/OR GARAGE SALE PERMIT APPLICATION INSTRUCTIONS & CONDITIONS

Per Sec. 9-4.2519 (C) (5) of the Thousand Oaks Municipal Code, a "Multiple Residence Boutique and/or Garage Sale Permit" must be obtained from the Community Development Department for a boutique sale or if more than one residence or parcel will be the site of the sale. (Boutique sale refers to a sale from a residence or residential property of small handcrafted items produced entirely by local persons within their own residence.)

Standard Conditions:

- 1. No single sale shall be conducted for longer than two (2) consecutive weekends, or seventy-two (72) hours, whichever is the lesser.
- 2. Sale shall be conducted during daylight hours only.
- 3. Property/items for sale can only be displayed on driveway, in garage and/or in a rear yard. No items shall be displayed in any front yard or public right of way.
- 4. "Multiple Residences / Boutique Garage Sale Permit" must be displayed.
- 5. Applicant shall monitor parking for violations. No illegal parking shall be permitted.
- 6. A maximum of two (2) garage sale signs are allowed on private property of residences holding the sale the duration of the sale only. An additional two (2) off-site directional signs may be permitted provided the premises upon which the garage sale or boutique sale is conducted is not on a major thoroughfare, and written permission to erect such signs is received from the property owners on whose property such signs are to be placed.
- 7. No signs are allowed in public rights of way, including utility poles, traffic sign poles or medians.
- 8. Applicant shall be responsible for the cost of any extraordinary police response associated with the sale.
- 9. Participating addresses will be utilizing one of the 2 garage sales allowed by the Municipal Code per premises per calendar year.
