Area Housing Authority

The Area Housing Authority of the County of Ventura (AHACV) is a Public Housing Authority representing seven jurisdictions, including the cities of Camarillo, Fillmore, Ojai, Moorpark, Simi Valley, Thousand Oaks, and the County of Ventura.

AHACV serves as the City of Thousand Oaks' Housing Authority and represents each of its seven-member jurisdictions in that capacity.

AHACV is governed by a Board of 15 Commissioners, two appointed from each of the seven local government jurisdictions and one "at-large" resident Commissioner appointed by AHAVC and confirmed by seven local government jurisdictions.

Agency Commissioners are appointed for four-year terms, and the resident Commissioner, by state law, serves a two-year term.

On behalf of its member agencies, AHACV implements the Federal Section 8 Rental Subsidy Program for residents within its member jurisdictions and owns and manages public housing units within Ventura County.

Membership shall represent a mix of arts organizations, working artists, and arts educators. Members must be at least 18 years of age and must be an arts educator or working artist residing in Thousand Oaks, or a representative of an arts organization located in and/or doing business in the City. Members may not be officials or employees of the City and no organization may have more than one representative on the Roundtable at any given time.

The Business Roundtable was established as an advisory body to the City Council regarding City Council approved business-related topics. The Business Roundtable reviews and advises City Council of local business issues within the community; goals and workplans are presented to City Council annually for input and approval; City Council may refer other issues to Business Roundtable for review; Business Roundtable submits an annual report on Business Roundtable activities and any other periodic reports deemed appropriate by the Committee or directed by City Council.

The Business Roundtable has 11 members consisting of 10 at-large (appointed by City Council) and one Greater Conejo Valley Chamber of Commerce representative. Members must be a City resident, City business owner, or an employee of a City business with experience in business operations and/or management. Conflict of Interest filing is required.

At-large members serve two-year, rotating terms, the Greater Conejo Valley Chamber of Commerce member has no term limit.

Community Funding Review Committee

The Community Funding Review Committee (CFRC) acts in an advisory capacity to the City Council relative to funding recommendations of community grants administered by the City Manager's Office. The Functions and duties of the CFRC is to 1.) Review all eligible funding applications received by the City in a manner consistent with adopted procedures and criteria for each grant program; and 2.) Make recommendations to the City Council for grant awards at the close of each funding application cycle.

Community grants include Community Environmental Enhancement Grants (supports projects having an environmental benefit across a wide cross-section of Thousand Oaks), Community Events Grants (supports artistic and cultural events and activities), Community Social Services Grants (operational support grants to non-profit agencies assisting primarily lower-income City residents), and Community Sports Grants (supports building or improvement of existing sports fields or facilities and equipment purchase for use by the community).

Members serve three-year rotating terms.

The purpose of the Conejo Open Space Conservation Agency (COSCA) is to conserve natural open space land areas; assure coordination of local land use and resource management decisions relating to open space and land areas; and function as an entity to focus community resources towards achievement of adopted general plan goals pertaining to open space and natural resources.

COSCA is governed by a five-member Board of Directors which consists of two City Councilmembers, two Conejo Recreation and Park District (CRPD) Board members and one public member. The public member must be a resident within the City limits or the CRPD boundary. Conflict of Interest filing is required (VC Clerk of the Board is filing official).

The public member serves four years. The public member nominee is submitted to both the City Council and CRPD for mutual agreement of the appointment.

The Santa Monica Mountains Conservancy Advisory Committee (SMMCAC) is a 26-person committee that provides input to the Board of Directors of the Santa Monica Mountains Conservancy on issues related to open space preservation and acquisition.

The SMMCAC is comprised of 17 representatives of cities and counties within or near the Santa Monica Mountains, 6 public members, and 3 representatives from regional park districts within the Santa Monica Mountains. The Thousand Oaks City Council appoints one resident of Thousand Oaks to the SMMCAC to represent the City. The City of Thousand Oaks' representative to the SMMCAC serves a two-year term.

The SMMCAC has the following duties:

- Propose and review projects for action by the Conservancy Board of Directors and report to the Board regarding the conformity of the projects with the Santa Monica Mountains Comprehensive Plan
- Review proposed amendments to the Santa Monica Mountains Comprehensive Plan.
- Provide opportunities for public participation.

As the SMMCAC meets jointly with the Santa Monica Mountains Conservancy Board of Directors, the basic duty of an SMMCAC member is to deliberate and vote on each item with the AC and pass that recommendation on to the Conservancy Board during the joint meeting.
